The specifications correspond to the regulations for Germany. Take the legal situation in your country into account.

General information: CS sprays with a defined amount of active substances have been approved for use against human attacks by the Federal Criminal Police Office (BKA) after prior testing by the Physikalisch-Technische Bundesanstalt (PTB). These sprays are provided with a corresponding BKA test mark. However, a PTB test mark for self-defence sprays is not necessary, as these are socalled "irritant sprayers" and not irritant weapons. The PTB test mark can only be found on signal, alarm or irritant weapons or their ammunition. This is stipulated in the General Weapons Act. Animal defence sprays are not irritant weapons according to the definition of the law and are therefore not subject to BKA or PTB labelling. While the irritants "CS" and "CN" respond to receptors (nerves), the active pepper affects reflexes such as breathing, eyelid cramps, coughing and sneezing. The active ingredient "OC" (Oleoresin Capsicum) is obtained from the commercially available red chilli pepper "Teja Variety Chilli" and contains the decisive spiciness together with capsaicin.

Legal situation: Pepper sprays must be clearly identified as "animal defence spray". Pepper sprays, as well as other utensils within reach, may be used against human attackers in self-defence or an emergency to avert a current, illegal attack on yourself or someone else. Proportionality must be maintained here. But anyone who uses a pepper spray without having been seriously in danger is committing grievous bodily harm and therefore a criminal offence. This is also the case if the spray is used for too long or too intensively, i.e. the culprit is already lying defenceless on the ground and continues to be "sprayed" out of fear, panic or even revenge.

Animal defence sprays are not covered by the Weapons Act, so are not weapons and can therefore be sold freely without age restrictions. This is stipulated in Article°40 (Prohibited Weapons) and the corresponding Appendix°2 (1.3.5). If you want to purchase CS products that are approved for defence against people, you must be at least 14 years old.

Self-defence (German Penal Code - StGR Article°32 ff.)

Anyone who commits an act that is advisable for self-defence is not acting unlawfully. Self-defence is the defence required to avert a current illegal attack on yourself or someone else.
